**WHEREAS** the Customer wishes to contract the goods and/or services of the Contractor to provide the requested inventory and/or specific personnel services as described in page 3: Attached Inventory hereto (the "Inventory"), and/or the necessary or required technical personnel (the "Personnel") necessary to operate the Inventory as set out in page 3;

**NOW THEREFORE THIS AGREEMENT WITNESSES** that in consideration of the mutual covenants and agreements contained in this Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties, the parties hereby agree as follows:

1. The Contractor hereby agrees to provide the Inventory and/or Services specified in page 3, both of which schedules are attached hereto and made a part hereof, for the contract price of:

Contractor warrants that the Inventory is in usable working order and meets the specifications as originally presented to the Customer, and that any Personnel are properly trained and sufficiently competent as per the services for which they are hired.

2. The Contractor shall have the Inventory available and ready for pickup by 6 a.m. (unless otherwise arranged with Contractor) of the first day of the Inventory Rental Period as described in page 2.

3. The Contractor shall refer Personnel services as requested by the Customer to such production's location by the production call time.

4. The Customer shall provide any call time(s) or requests required for Personnel services no less than 72 hours in advance to the production call time(s).

5. The Customer shall pay for any requested Personnel services (not-limited to re-enactor extras) no less than 24 hours in advance to the production call time(s).

6. The Customer shall pay to the Contractor the said amount as described in page 3 upon the execution of this Agreement as a non-refundable deposit for Contractor's Inventory and/or services. At the completion of rental period and all Inventory has been accounted for, the Contractor shall refund to the Customer minus any damages or additional fees, in check, the amount of the Security Deposit. Should the amount in damages or fees exceed the Security Deposit, the Customer shall pay the Contractor such additional amount.

7. The Customer shall have returned all Inventory no later than 11:59 p.m. (unless otherwise arranged with Contractor) of the Inventory Return Date as described in page 2.

A contractor is defined by a person or business which provides goods or services to another entity under terms specified in a contract or implied agreement and who is not subject to the other's control, or right to control, the manner and means of performing the services; not as an employee. Also called independent contractor.<sup>1</sup> One who engages an independent contractor is not liable to others for the acts or omissions of the independent contractor.
